FOR INDOOR USE: Follow ants back to voids. Apply product where ants are active, to cracks and crevices, voids or other areas that are inaccessible to children and pets. In heavily traveled sites use up to 42 g product. Use a large Centrobulb* puffer, duster or other appropriate application device to place the product into crevices or voids. Bait may be placed at same rate in appropriate child resistant bait stations that are secured in place. Place bait stations next to sites of ant activity or suspected ant activity areas. Repeat baiting when bait is consumed or no longer palatable. Bait must be placed in areas inaccessible to children and pets.
